



## Minutes of the Alabaster City Council Meeting

#### 1. Resolution 060120      Authorizing Vehicle Purchase for Environmental Services

Council Member **Ellis** introduced in the form of a motion, **Resolution 060120**, authorizing request for a vehicle needed for the Environmental Services Department at a cost of \$26,500. Purchase of a Toyota RAV4 from Limbaugh Toyota complies with State Bid Law due to being purchased off the State Bid List - Contract number T191. Vehicle purchase price is \$24,909.50 and upfitting safety lighting will not exceed \$1,590.50. Council Member **Rakestraw** seconded. Council President **Brakefield** called for a roll call vote.

**2. Resolution 060120-A Authorizing Purchase of Water Reclamation System for Waste Water Treatment Plant**

Council Member **Martin** introduced in the form of a motion, **Resolution 060120-A**, authorizing the purchase of a Self Primer Water Reuse Package water reclamation system from Clay-Greene Package Pump Stations at a cost of \$49,976.83. The 125GPM pump will improve efficiency and reduce running cost for the WWTP. Council Member **Bedsole** seconded. Council President **Brakefield** called for a roll call vote.


